### CONDITIONS OF CONSENT

1. This consent is valid only for the approved production capacity of Lucknow Health City Trauma Centre and Super Speciality Hospital Pvt Ltd, NH A and B/2, Vijay Khand 2, Gomti Nagar,, LUCKNOW, Health -care Establishment ( as defined in BMW Rules) for 100 Bedded Hospital with CTO valid up to 31.12.2023.
2. This consent is valid only for products and quantity mentioned above. Industry shall obtain prior approval before making any modification in product/ process /fuel/ plant machinery failing which consent would be deemed void.
- 3(a) The maximum rate of emission of flue gas should not be more than the emission norms for the stacks.

4. Quantity of other pollutants should also be as per the norms prescribed by the Board/MOEF & CC/or otherwise mandatory .
5. The equipment for air pollution control system and monitoring ,as proposed by the industry and approved by the Board should be installed in their premises itself .
6. The modification or installation in the existing pollution control equipments should be done only by prior approval of Board .
7. The operation of air pollution control system and maintenance be done in such a way that the quantity of pollutants should be in accordance with the standards prescribed by the Board/MoEF & CC/or otherwise mandatory .
8. Unit should do provisions for fugitive emissions chimney/stack as per the norms of the Board/MOEF & CC/or otherwise mandatory .
9. The unit should submit the stack emissions monitoring report within one month from issuance of consent order along with the point wise compliance report of the consent order . Further quarterly monitoring report should be submitted .

**The Unit will file the renewal application at least 2 months prior to the expiry of this Order.**  
**Specific Conditions:**



1 M/s Lucknow Health City Trauma Centre and Super Speciality Hospital Pvt Ltd, NH A and B/2, Vijay Khand 2, Gomti Nagar,, LUCKNOW, Health -care Establishment ( as defined in BMW Rules) for 100 Bedded Hospital with CTO valid up to 31.12.2023. For renewal of the consent, application in the prescribed form shall be submitted through the web portal of the Board for Online Consent Management & Monitoring System 2 months prior to the date of expiry.

2. This consent is granted subject to the power of the Board to review and make variation in or revoke any of the conditions as the Board deems fit as per the relevant Acts/Rules.

3. The applicant shall comply with the instructions that the Board may issue from time to time regarding prevention and control of air and sound pollution.

4. No change or alteration of the Hospital is to be made without the prior written permission of the Board. Any change in the particulars furnished and/or in the identity of the occupier/authorized person is to be intimated to the Board forthwith.

5. Arrangements for collection, segregation, storage, handling and disposal of solid Waste including Bio Medical Waste shall be provided and maintained properly as per the prescribed rule.

6. This consent is granted on the basis of the other documents furnished by the applicant. If the statement furnished in document is found false or in the case of noncompliance of integrated consent to operate conditions the consent issued will be withdraw/cancelled.

7. The applicant shall submit separate application for obtaining Consent for Operation/ Renewal under Air (Prevention and Control of Pollution) Act, 1981 before 60 days of expiry of validity period of Consent.

8. Solid waste and BMW generated from Hospital will not be allowed for open burning in the premises or around the Hospital area .

9. Regulations and conditions of the explosive and fire safety authorities shall be strictly adhered to all the time.

10. This CTO is valid for the compliance of BMW Rules 2016 and will submit the compliance report.

11. Consent is granted subject to be submit of the stack monitoring analysis report of stack from any approved lab within one month from the issuing date of consent.

12. The Board has rights to revoke the issued consent if hotel found in non compliance of the conditions during sudden inspections.

13. The Hospital shall abide by directions given by Hon'ble Supreme Court, High Court, National Green Tribunal, Central Pollution Control Board and Uttar Pradesh Pollution Control Board for protection and safeguard of environment from time to time.

14. Balance consent fee if there will be payable within 15 days of time from the issue of this Consent.

15. The condition of the confirmation that the found complaint was, then consent order itself will be automatically canceled.

16. There shall not be any fugitive emission from the premises.

17. Each of the D.G.Sets shall be provided with a stack whose height, should be worked out according to the formula ie  $H = h + 0.2 \text{ capacity of KVA}$ . Where  $h$  = height of the building in meters where the generator set is installed.

18. Exhaust stack of 125, KVA and 200 KVA (02) DG sets should be prescribed height above roof top and for control noise acoustic enclosure should be installed. DG set should be operated only in absence of electricity supply.
